

Bi-Functional Substance Declaration Guidelines

Dear Customer,

The following Fermentek substances and their derivatives are classified as "bi-functional" or "controlled" materials and require an export license:

- Aflatoxins
- Diacetoxyscirpenol
- HT-2 toxin
- Microcystins (Cyanoginosins)
- T-2 toxin

To obtain an export license for these substances, we must submit a request to the Israeli authorities, accompanied by your declaration of the intended usage of the materials.

Here are guidelines on how to fill out the required declaration:

Declaration Forms

There are two available declaration forms:

1. [End-User Declaration](#)
2. [Distributor Declaration](#)

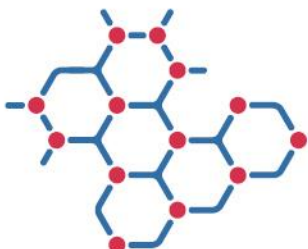
The title of both declarations is the same, but there are differences between them (11 sections in the end user form, and 9 in the distributor form)

Important: It is mandatory to fill out the correct form as any deviation will result in rejection.

Who Should Use Each Form?

End-User Declaration

This form is for customers who use the substances for internal purposes such as scientific research, analytical tests, services, or quality control. It is also for manufacturers who use the substances in their manufacturing processes, even if the final product is intended for distribution. For example, a manufacturer of analytical test kits is considered an "End-User."



When filling out the End-User Declaration form, please note:

- Do not fill sections 5, 5a, and 5b.
- Section 6a: Specify the number of vials and quantities in each vial (e.g., 2x10mg).
- Section 9: Provide a detailed description of the intended usage that supports the requested quantities.
- Do not fill and sign section 10.
- Section 11: Complete all requested details including name, title, signature, date, and company stamp.

Agent Declaration (Subcase of End-User Declaration)

This is used when materials are intended to be sold by the customer to a known end-user. Both the customer (referred to as "CONSIGNEE") and the End-User must fill out and sign the form.

When filling out the "End-User Declaration" form in this outline, please note:

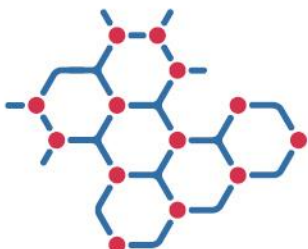
- Fill sections 2, 3, and 4 with the end-user details.
- Fill sections 5, 5a, and 5b with your (the "agent" or "CONSIGNEE") details.
- Section 6a: Specify the number of vials and quantities in each vial (e.g., 2x10mg).
- Section 9: Provide a detailed description of the intended usage by the end-user.
- Fill out and sign section 10 with your full details as requested including name, title, signature, date, and company's stamp.
- Section 11: The end-user should complete all requested details including name, title, signature, date, and company's stamp.

Distributor Declaration

This form is for customers who purchase substances to stock and sell them to currently unknown end-users and/or in unknown quantities.

When filling out the form, please note:

- Section 5a: Specify the number of vials and quantities in each vial (e.g., 2x10mg).
- Section 8: Provide a detailed description of the intended usage by the end-users.
- Section 8: List the countries where you intend to sell the substances. Generalizations such as "Western Europe" or "EU countries" are not accepted.
- Section 9: Complete all requested details including name, title, signature, date, and company stamp.

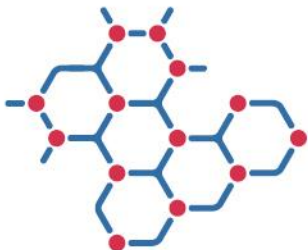


Important: For a distribution license, there may be limitations and conditions that you must comply with (e.g., export restrictions and semi-annual sales reports).

Company Details

Please also fill out the attached "Company Details" Word document. These details are necessary for us to complete the license request. Provide as much detail as possible about the intended use of the substances, your company's relevant occupation, and a link to a relevant webpage that supports your stated needs.

In the case of an "Agent Outline," the end-user should also fill out a "Company Details" form.
